Driving authorization

On a regular basis a working group of German proving ground operators and OEMs exchanges information about the contents of the basic driving qualifications. It is within the discretion of the operator, to recognise the driver qualification from partner proving grounds as equivalent. Please note that the recognition of your qualification must be clarified with the relevant operator. The recognition of your qualification at ATP is the sole responsibility from the respective operator. Please note that you might need further qualifications and trainings, this depends on the driving programs.

Participation requirements

- The participant needs to hold a valid in Germany accepted driving license for passenger vehicles
- The participant should be familiar with vehicles with manual transmission
- Ideally you have already absolved a driver safety training – we would be pleased to assist you in order to be well prepared
- This training is offered in English (trainings in German will be listed separately)
- The training exercises will be evaluated. In case of achieving an adequate result at the end of the training, you will receive the proving ground driving license and a certificate
